AGENDA APPROVAL – Motion by Blough, seconded by Anderson, to approve the agenda as presented. Motion carried.

MINUTES – Motion by Vanderziel, seconded by Benedict, to approve the minutes of the regular meeting November 20, 2017, as presented. Motion carried.

TREASURER'S REPORT – Motion by Burtt, seconded by Vanderziel, to accept the Treasurer's report as presented. Motion carried.

The Supervisor reported on a meeting that Lowell Township had with the City of Lowell regarding the recent sewer rate increase for Lowell Township.

<u>North Park Update</u> – Guy Nelson, TEG Civil Structural, gave an overview of the progress to date on the North Park. He reviewed the quote from Western Wood Structures regarding the boardwalk approaches and bridge railing costs. The Board discussed boardwalk approach alternatives and cost comparison.

<u>Western Wood Structures, Inc. Sales Order</u> – Motion by Vanderziel, seconded by Anderson, to approve the sale order agreement with Western Wood Structures for the Glulam Truss Bridge for a total cost of \$1,073,700.00 and to submit a 10% down payment for \$107,370.00. Also, making a recommendation to extend the one-year warranty (included) to a ten-year warranty and to acquire clarification on balance due date of net 30 days. Motion carried.

<u>Payment Application Approval</u> – Motion made by Vanderziel, seconded by Burtt, to approve Payment Application No. 3, for North Grand River Park - Phase III for \$42,428.25 to Groundhawg Excavating, LLC. Motion carried.

<u>Change Order No. 2</u> – Motion by Vanderziel, seconded by Anderson, to approve Change Order No. 2 to the North Riverfront Park – Phase III contract for \$48,883.00 to prepare the bridge construction staging area and access drive on the North side of the river. Motion carried.
